Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25. You may register your dog online at <http://nasda.dog/registration/>. (Registration number can be acquired at the trial site).

Awards:

Ribbons are awarded for qualifying score, Best of Breed and High in Class.

Rosettes are awarded for New Titles.

Each week the 1st place dog (Cumulative high in trial points) will be awarded 1 free run at a future CSDS trial.

After the final week is complete, the following will be awarded based on total number of cumulative high in trial points across the 6 weeks: #1 - 6 free runs + gift basket, #2 - 4 free runs, #3 - 2 free runs

Venue:

Exhibitors will have the option of indoor, climate-controlled crating or crating in their vehicles. No idling vehicles! Common Scents Dog Sports reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

Notice to Exhibitors:

- No refund for cancellations after the closing date. Cancellations before the closing date if paid via cash or check will receive a full refund. If paid via PayPal Goods and Services or via Stripe, cancellations will be refunded minus a 5% fee.
- No refunds will be made for cancellations after the closing date, or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries are not valid until entry fees are paid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment.
- Common Scents Dog Sports reserves the right to refuse any entry without cause or explanation.
