#### Venue:

Exhibitors will be crating in their vehicles. Common Scents Dog Sports reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

#### **Notice to Exhibitors:**

- Cancellations before the closing date if paid via cash or check will receive a full refund. If paid via PayPal or via Stripe, cancellations will be refunded minus a 5% fee.
- No refunds will be made for cancellations after the closing date, or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.

- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees in order to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment.
- Common Scents Dog Sports reserves the right to refuse any entry without cause or explanation.
- Trial begins at 8:00 AM.
